

CHAPTER 1810

Resident Camps and Day Camps

EDITOR'S NOTE: Chapter 1810 sections 1810.01 through 1810.04(b) and sections 1810.06 through 1810.24 were replaced by Resolution 158-02 adopted June 13, 2002. Under authority of ORC 3709.21, the Summit County Board of Health administers and enforces OAC 3701-25-01 through 3701-25-43 pertaining to resident camps and day camps. This responsibility includes plan approval, licensing, and all other acts or efforts necessary to assure compliance with the requirements of the resident camps and day camps rules. The Resident Camps and Day Camps rules are contained in a booklet published by the Ohio Department of Health, copies of which are available for distribution by the Summit County Board of Health.

1810.04 PERMIT TO OPERATE; REVOCATION.

The Board may suspend, revoke or refuse to issue a permit for a violation of any of the provisions of this chapter, subject to the general procedures for hearing and appeal prescribed by ORC 119.07, 119.08, 119.09, 119.091, 119.12 and 119.13. Such suspension, revocation or refusal to issue may be made prior to hearing if, in the judgement of the Board, the violation on which such action is based constitutes a serious public health hazard.

1810.05 INSPECTION FEE.

An annual inspection fee shall be levied upon each camp for the purpose of enforcing this chapter and paying the expenses of such inspection. The inspection fee for a camp shall be set forth in section 220.08 of the Administration Code. In the event the camp is operated by a voluntary agency, fraternal organization, church or for the benefit of underprivileged children the permit fee shall be as set forth in section 220.08 of the Administrative Code.

1810.99 PENALTY.

Whoever violates or fails to comply with any of the provisions of this Environmental Health Code shall be in violation of ORC 3707.48, 3709.20, 3709.21 or 3709.22, and subject to penalties provided in ORC 3707.99 and 3709.99.
